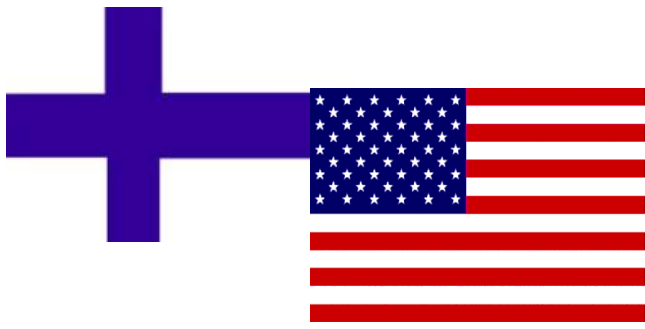

### **Friday, September 17, 2010**

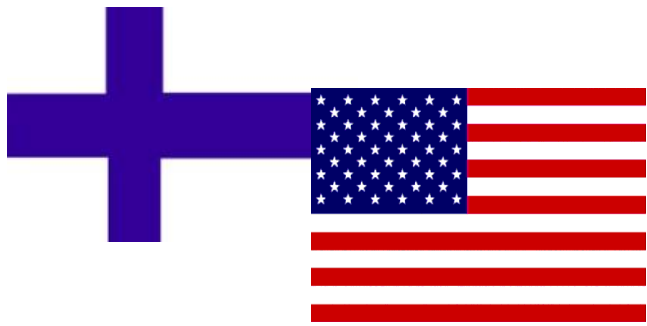

2:45PM Depart from in front of the Brio Tuscan Grille to return to the Holiday Inn Westlake

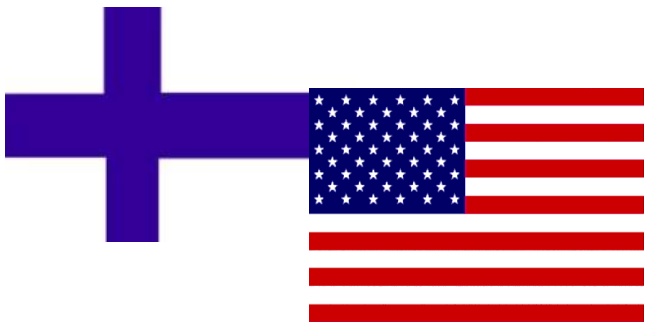
